ALL MAKES AND MODELS WILL BE INCLUDED IN EACH CLASS

Mild Custom: Bolt on chrome accessories, including exhaust and wheels; original or original style paint; pinstriping or surface artwork on original paint; no frame or sheet metal modifications.

Custom: Bolt on chrome accessories, including exhaust and wheels; front end changes; wide rear tire conversions; sheet metal modifications; custom paint; custom or modified frame.

Old school Bobber: Stripped down style, solo seat, built with new or newer components to give the appearance of a nostalgic motorcycle.

Rat Bike: A motorcycle that has fallen apart over time, and on the road for maximum amount of time, while spending as little as possible, adaptation and use of parts that were not designed to fit the bike.

Antique: 25 years or older

Competition Bike: drag race, flat track, hill climb, ice racer, trials, road race, etc... 24 years old or newer.

Antique Competition Bike: drag race, flat track, hill climb, ice racer, trials, road race, etc... 25 years and older

Custom Pro Street: Special Construction motorcycle, long, low stretched style motorcycle built from components or scratch.

Custom Chopper: Special construction motorcycle, longer back bone and down-tubes on frame, raised steering neck and gas tank, built from components or scratch.

Café Racer: A light-weight, stripped down, motorcycle with low slung racing handlebars puts café racers in a unique class.

Custom Bagger: Factory touring bike with bags. Fairing and tour pack optional. Modified frame, triple trees, or both; modifications to paint, engine, seat, exhaust, suspension, wheels/tires, and accessories.

Mini Bike: Bikes 70 CC or smaller, 14" inch wheels or smaller and air cooled.
